

Little Wing x The Copeland Distillery Competition

Terms and Conditions

1. The Promoters

This competition is jointly promoted by Little Wing and The Copeland Distillery (together, the “Promoters”). By entering the Competition, entrants agree to be bound by these Terms and Conditions.

2. The Competition

The Competition offers entrants the chance to win one of the following prizes:

- 1st Prize: One (1) distillery tour for four (4) people
- Runner Up Prize 1: One (1) distillery tour for two (2) people
- Runner Up Prize 2: One (1) distillery tour for two (2) people

The distillery tour includes tasting of award-winning spirits, a guided explanation of the production process, and storytelling about the history of the local area.

3. Eligibility

The Competition is open to all persons aged 18 years or over at the time of entry, except:

- Employees, agents, or contractors of the Promoters or their immediate family members
- Any person involved in the administration of the Competition

Entrants must be aged 18 or over due to the nature of the prize (alcohol tasting). The Promoters reserve the right to request proof of age before awarding any prize.

4. How to Enter

To enter the Competition, entrants must complete and submit the entry form in full. No purchase is necessary. Only one entry per person is permitted. Entries must be submitted before the closing date.

Entries that are incomplete, illegible, or otherwise not in accordance with these Terms and Conditions will be disqualified.

5. Closing Date

The Competition closes at 11:59pm on 30 August 2026 (the “Closing Date”). Entries received after this date will not be accepted.

6. Winner Selection

Winners will be selected at random from all valid entries received on or before the Closing Date. The draw will take place on 31 August 2026. The Promoters’ decision is final, and no correspondence will be entered into regarding the selection process.

7. Notification of Winners

Winners will be notified using the contact details provided at the time of entry. If a winner cannot be contacted within 14 days of notification, or is unable or unwilling to accept the prize, the Promoters reserve the right to withdraw the prize and select an alternative winner.

8. The Prize

The prize is as described in Section 2 above. The prizes are non-transferable, non-exchangeable, and have no cash alternative. The Promoters reserve the right to substitute a prize of equal or greater value if circumstances require.

The Copeland Distillery Tour is subject to availability and must be booked in advance. Tours are available on selected dates and are subject to the Distillery's standard booking terms. Travel to and from the Distillery is not included.

9. Data and Privacy

Personal data submitted as part of the competition entry will be used for the purpose of administering the competition, contacting winners, and for marketing communications from The Copeland Distillery. This may include news, offers, events, and updates about The Copeland Distillery's products and services.

By entering the Competition, you consent to your personal data being used for these purposes. You may withdraw your consent and opt out of marketing communications at any time by contacting The Copeland Distillery directly or using the 'unsubscribe' button at the bottom of emails.

Data will not be shared with third parties except as required to fulfil the prize or as permitted by applicable data protection law and will be retained only for as long as necessary. For more information, please refer to The Copeland Distillery's privacy policy.

10. Publicity

The Promoters reserve the right to use the name and general location of winners for publicity purposes (such as social media announcements), unless the winner objects. Winners may opt out of publicity by notifying the Promoters at the time of accepting the prize.

11. General

The Promoters accept no responsibility for entries that are lost, delayed, or corrupted. The Promoters reserve the right to cancel, amend, or suspend the Competition, or amend these Terms and Conditions, at any time without notice, where circumstances beyond the Promoters' control make it necessary to do so.

These Terms and Conditions are governed by the laws of Northern Ireland and any disputes shall be subject to the exclusive jurisdiction of the courts of Northern Ireland.
